The sealed Tender should reach the office, latest by 31<sup>st</sup> August 2023 at 05:00 PM and it will be opened on 01<sup>st</sup> September 2023 at 11:00 AM in the Admin building of the Gujarat National Law University, Gandhinagar, in the presence of the bidder(s) or their authorized representative(s), who will be present at the scheduled date and time.

## **General Terms and Conditions**

1. The tender should be submitted in two parts i.e., Technical Bid and Financial Bid. The Technical Bid should be sealed by the bidder in separate covers "Technical Bid for Supply & Installation of Air-Conditioning" for Supply & Installation of Air-Conditioning". Both sealed envelopes should be kept in a main/bigger envelope super-scribed as "Tender for Supply & Installation of Air-Conditioning". Financial Bids shall be submitted online only at website: <https://www.nprocure.com>.

### **Documents comprising in technical bid-**

1. Duly filled format of technical bid as per Annexure-II and certificate given in Annexure III.
2. Copy of constitution or legal status of the bidder/ manufacturer/ Sole proprietorship/ firm/ agency etc.
3. Signed each page of tender document.
4. The technical bid should be accompanied by Demand Draft of Earnest Money Deposit and tender fee.
5. Copy of Income Tax Return Acknowledgement for last three years.
6. Copy of PAN card/ Service Tax Registration.
7. Copy of GST registration certificate.
8. Bidder must be authorized distributor/ Dealer/ Sub Dealer of Air Conditioner of recommended make.

### **Documents comprising in Financial bid-**

2. Earnest Money Deposit (EMD): The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of 1,00,000/- (Rupees one lakh Only) by way of demand drafts only. The demand draft shall be drawn in favour of "The Registrar, Gujarat National Law University, payable at Gandhinagar/Ahmedabad". The demand draft for earnest money deposit must be enclosed in the envelope containing the technical bid.
  - a. Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with stipulation made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeite.
  - b. The tender without earnest money deposit will be summarily rejected. The firm who are registered with National small Industries Corporation (NSIC)/OR small scale industries (SSI) are exempted to submit the EMD(Copy of registration must be provide along with technical bid).
  - c. The EMD, in case of unsuccessful bidders shall be retained by this office till the finalization of the tender. No interest will be payable by this office on the EMD.
  - d. The EMD of successful bidder shall be returned after successful delivery and installation.
3. **Rates:** Rate should be quoted inclusive of delivery charges, Supply and Installation including core cutting (if required), and in Indian Rupees (INR. Where there is a difference between the rates in figures and words, lower of the two rates shall be taken as valid and correct rate.
4. The sealed quotations/tender, super scribed with the name of the work, reference number, should be submitted in person or by post. However the University shall not be responsible for delay or loss of tenders in transit or any postal delay

5. **Opening of Tender:** The tenderer is at liberty either himself or authorize not more than one representative to be present at the opening of the tender. The representative attending on the opening of the tender on behalf of the tender should bring with him a letter of authority from the tenderer and proof of identification. The late received tenders will be ignored. Further, this office does not accept any liability and responsibility for the tenders in case the same are not properly sealed and marked and/or sent as above.
6. Tender inviting officer reserves the right to accept or reject any or all quotations without assigning any reason thereof and do not bind himself to accept the lowest tender.
7. Delayed/ late/ conditional quotations/tenders shall not be accepted at all.
8. **Validity of the bids:** The quoted rates must be valid for a period of 60 days from the date of closing of the tender. The overall offer for the assignment and bidder(S) quoted price shall remain unchanged during the period of validity. If the bidder quoted validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.
9. In case the tenderer withdraws, modifies or change his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof. The tenderer should also be ready to extended the validity, if required, without changing any terms, conditions etc. of their original tender.
10. Authority of person signing document: - A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty, that he has authority to bind such other and if, on enquiry, it appears that the person so, signing had no authority to do so, the Office may without prejudice to other Civil and criminal remedies cancel contract and held the signatory liable for all cost and damages.
11. Performance security Deposit: The successful tenderer will be required to furnish a Performance security Deposit equal to 5 -10 % of the contract value after receiving purchase order in the form of Fixed Deposit Receipt or Bank Guaranty from any Nationalized bank duly pledged in the name of the “ The Registrar, Gujarat National Law University, Payble at Gandhinagar/Ahmedabad” Which shall be kept valid for a period of 60 days beyond completion of all the contractual obligations.
12. The Income Tax/ Any other Taxes as applicable shall be deducted from the bill unless exempted by the Income-tax department.
13. Award of Contract: After the evaluation of the bid(s) office will award the contract to the lowest evaluated responsive tenderer on composite basis. Conditional bid will be treated as unresponsive and will be rejected.
14. Delivery and Installation: ACs shall be delivered, and all work related to installation shall be completed within 15 days from the date of issue of work order by the institute. All the aspects of safe installation including civil and electrical shall be the exclusive responsibility of the supplier. If the supplier fails to complete the work on or before the stipulated date, then a penalty at the rate of 0.5% per week of the total order value shall be levied subject to maximum of 10% of the total order value.
15. Force Majeure: Any delay due to Force Majeure will not be attributable to the supplier.
16. Bidder shall submit a copy of the tender document and addendum/ corrigendum thereof, if any, with each page of this document should signed and stamped to confirm the acceptance of the entire terms and conditions as mentioned in the tender enquiry document.
17. Breach of Terms and Conditions: In case of breach of any terms and conditions as mentioned in tender, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by office in that event the EMD shall also stands forfeited.
18. Legal Jurisdiction: All legal disputes are subject to jurisdiction of Ahmedabad courts only.

19. Payment Terms-Payment shall be made to supplier within one month from submission of bills along with proof of supply and installation.
