- 5 The selected candidates claiming the reservation are required to submit a valid category certificate issued by the competent authority before making the payment of academic fees.
- 6 If suitable candidates are not found for General (W) – DDN and OBC(W) – DDN, then the seat may be offered to General-DDN and OBC-DDN male candidates.
- 7 If the candidates are not found for any specific category mentioned above on the date of on Spot- Counselling-cum-Admission process, the seats shall be converted into other categories as per the Conversion Policy of the University and shall be filled accordingly.
- 8 Vacant seats are as per the available seats till date. If there is any vacancy that arises after the announcement of this notification, the seats shall be considered and offered to received/reported candidates on 2nd August 2025, subject to eligibility criteria as applicable, against the specific category as appropriate.
- 9 **Payment of Academic Fees:** The provisionally selected candidates are required to carry all the necessary documents mentioned in the **Annexure-1**, and after the due verification only, candidate will be offered the admission and is required to pay **INR 4,000/-** to block the seat.
- 10 The Academic Fees (Rs. 2,58,000/-) is required to be paid within three days from the date of confirmation of provisional admission.
